FEDERAL GOVERNMENT GRANTS

Grant Title: Environmental Education Grants

Grantor: Environmental Protection Agency

Estimated Allocation: 2009 allocation is estimated at \$3.3 million, with awards ranging from \$7,000 to \$125,000.

Purpose of Grant: To support projects to design, demonstrate, or disseminate practices, methods, or techniques related to environmental education and teacher training.

Application Deadline: Recurring annually. Deadlines are announced in official Requests for Applications.

Criteria: Projects must address one of the following educational priorities: (1) Capacity Building; (2) Education Reform; (3) Community Stewardship; (4) Health; (5) Teaching Skills; or (6) Environmental Career Development. Funds may be used to train teachers or faculty, but may not be used for technical training of environmental management professionals. Eligible applicants include local education agencies, colleges/universities, state education and environmental agencies, nonprofit organizations, and noncommercial educational broadcasting entities. Beneficiaries may be schools or non-profit institutions.

How to Apply: Applicants submit an application package to their respective EPA Regional Grants Management Offices for grants requesting \$50,000 or less in Federal funds, and to the EPA Headquarters for larger grants. Applicants may be able to use www.grants.gov to electronically apply for certain grant opportunities under this CFDA. However, where possible it is preferable to submit applications and attachments on paper via mail.

Grant Title: Brownfields Training, Research, and Technical Assistance Grants and Cooperative Agreements

Grantor: Environmental Protection Agency

Estimated Allocation: Total allocations in 2009 are estimated at \$3,000,000. Average awards range from \$95,000 to \$625,000. Average project lengths span from two to five years.

Purpose of Grant: Training, research, and technical assistance to individuals and organizations, to facilitate the inventory of brownfields properties, site assessments, cleanup of brownfields properties, community involvement, or site preparation.

Application Deadline: Deadlines will be specified in Request for Applications or Request for Initial Proposals. Contact: Office of Brownfields and Land Revitalization, OSWER, EPA, Washington, DC 20460, David Lloyd, Director. Telephone: (202) 566-2777

Criteria: Applicants must be local governments, redevelopment agencies, non-profits, or consortia. Beneficiaries can be state, tribal, or local governments, communities with Brownfields sites and their residents, community groups, universities and colleges, industry, and other public and private institutions and individuals.

How to Apply: Some applications may be completed at www.grants.gov. Otherwise the standard application forms as furnished by the Federal agency and required by OMB Circular No. A-102 and A-110 must be used for this program. EPA requires final applications to be made on Standard Form 424. Requests for application kits must be submitted to the Environmental Protection Agency, Grants and Interagency Agreements Management Division, 3903R, Washington, DC 20460.

Grant Title: Brownfield Job Training Cooperative Agreements

Grantor: Environmental Protection Agency

Estimated Allocation: Total allocations in 2009 are estimated at \$2.5 million. Most awards are \$200,000, and most projects span 2 years.

Purpose of Grant: To recruit, train, and place unemployed and under-employed residents of brownfields-impacted communities, and by doing so, providing individuals of these communities with the skills needed to obtain sustainable employment in brownfields redevelopment and environmental related careers.

Application Deadline: Recurring. Proposal deadlines for selection of job training grant projects are announced in Requests for Applications.

Criteria: Proposals will be accepted from eligible governmental entities and non-profits, such as Workforce Investment Boards, and educational institutions. Trainees/beneficiaries must be residents of a neighborhood affected by a brownfield site. While no matching funds are strictly necessary, evidence of further funding is preferred.

How to Apply: Applicants may be able to use <http://www.grants.gov> to electronically apply for certain grant opportunities under this CFDA. EPA will specify application procedures in Requests for Applications. Paper application kits may also be acquired by writing to: Environmental Protection Agency, Grants and Interagency Agreements Management Division, 3903R, Washington, DC 20460.

Grant Title: Wastewater Operator Training Grant Program

Grantor: Environmental Protection Agency

Estimated Allocation: Total allocations are estimated at \$1.5 million. Average awards under this grant are \$25,000 per fiscal year.

Purpose of Grant: This grant provides funding for training and technical assistance to wastewater treatment systems. Improved operator training results in improved wastewater quality and no-cost troubleshooting assistance returns facilities to compliance.

Application Deadline: Historically, annual fiscal year funds have been appropriated by Congress, and are generally available in January to the Headquarters wastewater management program office. Contact the appropriate Regional Office for application deadlines.

Criteria: Eligible applicants include State and territorial agencies Native American Indian Tribes. Additionally, institutions of higher education and "not for profit institutions" may also apply for funding if acting as a designated organization of the State.

How to Apply: Applicants can usually use www.grants.gov to electronically apply for grant opportunities under this CFDA.

Grant Title: Capacity Building Grants and Cooperative Agreements for Compliance Assurance and Enforcement Activities in Tribal Areas

Grantor: Environmental Protection Agency

Estimated Allocation: 2009 allocations total \$300,000, with individual grants ranging from \$3,000 to \$100,000.

Purpose of Grant: Providing financial resources to build and improve the compliance assurance and enforcement capacity of federally recognized Indian tribal governments (tribes), inter-tribal consortia, or tribal organizations by providing financial resources and to improve compliance with environmental laws. As required by statute, such capacity building efforts may include economic, social science, statistical research, development, studies, surveys, demonstrations, investigations, public education, training, and fellowships.

Application Deadline: Recurring. The application deadlines are specified in the official Solicitations for Grant Applications. Check www.grants.gov for details.

Criteria: Eligible applicants include Tribal Organizations, Inter-tribal Consortia, Federal, and State Organizations, Colleges and Universities, and non-for-profit organizations.

How to Apply: Applicants may be able to use <http://www.grants.gov> to electronically apply for grant opportunities under this CFDA.

Grant Title: Energy Efficiency and Conservation Block Grants

Grantor: Department of Energy

Estimated Allocation: Total 2009 allocations are estimated at \$2.1 billion.

Purpose of Grant: The purpose of the EECBG Program is to assist eligible entities in creating and implementing strategies to: Reduce fossil fuel emissions in a manner that is environmentally sustainable and, to the maximum extent practicable, maximizes benefits for local and regional communities; Reduce the total energy use of the eligible entities; And improve energy efficiency in the building sector, the transportation sector, and other appropriate sectors.

Application Deadline: June 25, 2009, 8:00 p.m.

Criteria: Eligible applicants include state, county, and city governments, non-profits, and Indian tribes. Uses of funding include but are not limited to: Development of energy efficiency and conservation strategies, Technical consultant services, Residential and commercial building energy audits, Financial incentive programs, Energy efficiency retrofits, Development and implementation of transportation programs, Building codes and inspection, Energy distribution, and activities (including training) that support these functions.

How to Apply: Application forms and instructions are available at www.grants.gov. Once there, select "Apply for Grants," and then "Download Application Package." Enter CFDA number 81.128 and save the application package. Once you have SAVED the application package and completed all the required documentation, you will complete the application via the www.Fedconnect.net. DO NOT use the Save & Submit function in www.grants.gov.

Grant Title: Neighborhood Stabilization Program (NSP) 2

Grantor: Department of Housing and Urban Development

Estimated Allocation: Total 2010 allocations are estimated at \$2 billion.

Purpose of Grant: The Neighborhood Stabilization Program (NSP) was established for the purpose of stabilizing communities that have suffered from foreclosures and abandonment. A portion of the funds have been allocated to demolition of blighted structures, and this money can be used to train workers on deconstruction, a.k.a. building materials recycling. Deconstruction firms in Baltimore and Washington DC have teamed with local recyclers in successful grant applications.

Application Deadline: The current round of grant applications are due by July 17, 2009.

Criteria: Eligible entities are states, units of general local government, nonprofit entities, and consortia of nonprofit entities. Any lead applicant may submit a proposal in partnership with one or more for-profit entities. Proposals must be designed such that the Grantee expends at least 50% of its award within two years and 100% of its award within three years of the date the award is made.

How to Apply: Submit application form SF-424 to HUD. SF-424 is available for download from www.grants.gov. Applications must be received via paper submission to the Robert C. Weaver HUD Headquarters building by 5:00 PM on the deadline date.

Grant Title: Workforce Investment Act (WIA) – Dislocated Workers

Grantor: U.S. Department of Labor

Estimated Allocation: Total 2009 allocation is estimated at \$1.25 billion.

Purpose of Grant: To provide supplemental funds to States, Local Boards and other eligible entities to respond to the needs of dislocated workers in communities affected by major economic crises and other worker dislocation events.

Application Deadline: Continuous

Process Description: The federal government allocates grant money to states via a noncompetitive process. The state then allocates funds to each Workforce Investment Board (WIB), and WIBs partner with local organizations in issuing grants.

Criteria: Applicants may include states, local workforce boards, private and non-profit organizations whose purpose is to provide targeted assistance to dislocated workers. Beneficiaries are workers who have lost their jobs, including those dislocated as a result of plant closings or mass layoffs, the formerly self-employed, and displaced homemakers who have been dependent on income of another family member, but are no longer supported by that income. Individuals dislocated as a result of natural disaster may also qualify.

How to Apply: Contact your local Workforce Investment Board (WIB). A directory of WIBs is available at www.servicelocator.org.

Grant Title: Workforce Investment Act (WIA) – Youth

Grantor: U.S. Department of Labor

Estimated Allocation: Total 2009 allocation is estimated at \$1.2 billion.

Purpose of Grant: To help low-income youth acquire the educational and occupational skills, training, and support needed to achieve academic and employment success and successfully transition to careers.

Application Deadline: Continuous

Process Description: The federal government allocates grant money to states via a noncompetitive process. The state then allocates funds to each Workforce Investment Board (WIB), and WIBs partner with local organizations in issuing grants.

Criteria: Beneficiaries must meet the following criteria; (1) Must be 14 to 21 years of age; (2) Must be an individuals who received an income or is a member of a family that received a total family income that, in relation to family size, does not exceed the higher of (a) the poverty line; or (b) 70 percent of the lower living standard income; and (3) Must be an individual who is either illiterate, a school dropout, homeless, a runaway, a foster child, pregnant or a parent, an offender, or requires additional assistance to complete their education or secure and retain employment.

How to Apply: Contact your local Workforce Investment Board (WIB). A directory of WIBs is available at www.servicelocator.org

CFDA Number: 17.259

Grant Title: Workforce Investment Act (WIA) – Adult Program

Grantor: U.S. Department of Labor

Estimated Allocation: Total 2009 allocation is estimated at \$500 million.

Purpose of Grant: To improve the quality of the nation's workforce by bettering the occupational skills of participants, leading to increased employment, retention, and earnings.

Application Deadline: Continuous

Process Description: The federal government allocates grant money to states via a noncompetitive process. The state then allocates funds to each Workforce Investment Board (WIB), and WIBs partner with local organizations in issuing grants.

Criteria: Beneficiaries must be at least 18 years old. Low-income individuals and veterans generally receive preference, although no such written regulations exist.

How to Apply: Contact your local Workforce Investment Board (WIB). A directory of WIBs is available at www.servicelocator.org.

Grant Title: Green Jobs: Energy Efficiency and Renewable Energy Worker Training, i.e. "Green Jobs Act of 2007"

Grantor: U.S. Department of Labor

Estimated Allocation: Total 2009 allocation is estimated at \$500 million.

Purpose of Grant: To fund research, training, and job placement programs that prepare workers for careers in renewable energy, energy-efficient building, advanced drive train vehicles, biofuels, deconstruction/materials use, building efficiency assessment, and manufacture of products that use sustainable materials.

Application Deadline: Unspecified by issuing agency at the time of publication

Process Description: Funded by the American Recovery and Reinvestment Act. Official Solicitation for Grant Applications (SGA) not yet published.

Criteria: The partnerships must include business and labor, and may include other entities involved in education and training. The partnership must demonstrate experience in implementing training and education programs and in identifying populations who would benefit from the training. Priority is provided to partnerships that leverage other resources. This program requires grant seekers to comply with the Green Jobs Act of 2007 as it relates to eligible industries and target group priorities.

How to Apply: SGA not yet published. Check the Federal Register and www.grants.gov for upcoming details.

CFDA Number: Unspecified by issuing agency at the time of publication

Grant Title: YouthBuild USA

Grantor: U.S. Department of Labor

Estimated Allocation: Total 2009 allocation is estimated at \$50 million.

Purpose of Grant: Train disadvantaged youth for high-demand occupations, such as green jobs, while providing classroom time towards a GED or high school diploma.

Application Deadline: Varies by year. Check www.cfda.gov details.

Process Description: Grants for projects are awarded on a competitive basis. A review panel evaluates eligible submitted applications. The panel prepares a report for the Employment and Training Administration (ETA) Grant Officer identifying the strengths and weaknesses of the application. Once selections are made, an Award Notification is sent through the appropriate congressional channels.

Criteria: Qualifying recipients are public, private, or non-profit organizations, or consortiums of such organizations. Eligible uses include employment and training programs, youth development activities, counseling services, and wage subsidies for participants. Beneficiaries must be between 16 and 24 years of age upon enrollment, must be "disadvantaged," and must be a school dropout. Up to 25% of beneficiaries may not meet these requirements, but must lack basic skills or be referred by a local secondary school.

How to Apply: To compete for a grant, organizations develop a proposal and budget that demonstrate how the organization will provide services to a targeted population. Grants are published in the Federal Register; Grants.Gov; and ETA's home page at www.doleta.gov.

Grant Title: Energy Training Partnership Grants

Grantor: U.S. Department of Labor

Estimated Allocation: Unspecified by issuing agency at the time of publication

Purpose of Grant: To deliver training that leads to employment in careers in energy efficiency and renewable energy, specifically for dislocated workers. Grantees will utilize partnerships to design and implement training approaches that lead to recognized industry credentials and certifications, including registered apprenticeship. A portion of these funds will be reserved for regions where job losses have resulted from closed or restructured automobile plants.

Application Deadline: Unspecified by issuing agency at the time of publication

Criteria: Eligible applicants include: (1) national labor-management organizations with local networks; and (2) state and local non-profit partnerships between labor-management organizations, labor, business, Workforce Investment Boards (WIBs), and other organizations.

How to Apply: The official Solicitation for Grant Applications (SGA) has not been released as of the publication of this report. SGAs are expected to be announced in June 2009. Interested qualifying organizations should check www.grants.gov and www.doleta.gov/grants for official announcements.

CFDA Number: Unspecified by issuing agency at the time of publication

Grant Title: Green Capacity Building Grants

Grantor: U.S. Department of Labor

Estimated Allocation: Unspecified by issuing agency at the time of publication

Purpose of Grant: To support organizations as they update existing training programs for the emerging green economy, including training and job placement of workers into energy efficiency and renewable energy careers. Key uses include the purchase of new equipment, staff professional development, curriculum development/adaptation, partnership development, and, where necessary, hiring additional staff.

Application Deadline: Unspecified by issuing agency at the time of publication

Criteria: Grantees will be organizations already operating training programs funded by The U.S. Department of Labor.

How to Apply: The official Solicitation for Grant Applications (SGA) has not been released as of the publication of this report. SGAs are expected to be announced in June 2009. Interested qualifying organizations should check www.grants.gov and www.doleta.gov/grants for official announcements.

CFDA Number: Unspecified by issuing agency at the time of publication

Grant Title: Pathways Out of Poverty Grants

Grantor: U.S. Department of Labor

Estimated Allocation: Unspecified by issuing agency at the time of publication

Purpose of Grant: To provide training and placement services to impoverished, undereducated, and underserved individuals into careers in energy efficiency or renewable energy.

Application Deadline: Unspecified by issuing agency at the time of publication

Criteria: Eligible applicants include: (1) national community-based and faith-based organizations with local networks; and (2) local partnerships between community-based organizations, educational/training institutions, businesses, and labor. Successful applicants must include training and job placement services.

How to Apply: The official Solicitation for Grant Applications (SGA) has not been released as of the publication of this report. SGAs are expected to be announced in June 2009. Interested qualifying organizations should check www.grants.gov and www.doleta.gov/grants for official announcements.

CFDA Number: Unspecified by issuing agency at the time of publication

Grant Title: State Labor Market Information Improvement Grants

Grantor: U.S. Department of Labor

Estimated Allocation: Unspecified by issuing agency at the time of publication

Purpose of Grant: To disseminate labor market information, track workforce trends resulting from ARRA funds, and ensure that workers trained for green jobs will be able to find employment in the energy efficiency and renewable energy sectors. This means identifying the existing and emerging needs of employers in these industries and making available employee placement tools to help match workers with jobs. Work done by grant winners should complement and be coordinated with work done by the Bureau of Labor Statistics.

Application Deadline: Unspecified by issuing agency at the time of publication

Criteria: Grantees will be State Workforce Agencies (SWA) or consortia of multiple SWAs. Preference will be given to multi-state SWA consortia.

How to Apply: The official Solicitation for Grant Applications (SGA) has not been released as of the publication of this report. SGAs are expected to be announced in June 2009. Interested qualifying organizations should check www.grants.gov and www.doleta.gov/grants for official announcements.

CFDA Number: Unspecified by issuing agency at the time of publication

STATE GOVERNMENT GRANTS

Grant Title: Competitive Customized Training Grant Program

Grantor: New Jersey Department of Labor and Workforce Development

NOTE: Many other states have similar grant programs. Check with your state's Department of Labor for more information.

Estimated Allocation: Past awards have averaged roughly \$160,000.

Purpose of Grant: The purpose of these grants is to upgrade the skills of workers to ensure that New Jersey employers are competitive in the global economy. The program is designed to benefit both employees and businesses by enhancing the skills of workers, thereby increasing their productivity and the competitiveness of the employer. These grants are expected to result in the creation of new jobs, the retention of jobs and/or an increase in wages for the trained workers.

Application Deadline: Applications are accepted on a rolling basis. The final application deadline for fiscal year 2010 is May 5, 2010.

Criteria: Eligible applicants include individual employers, labor organizations, community organizations, and consortia. Employers must commit to retaining all trained individuals for at least six months following completion of the training program.

How to Apply: Applicants must first complete a pre-qualification questionnaire at www6.state.nj.us/DOL_CTTS/prequal/prequal2.jsp. Once completed, print a copy for your records and click "submit" on the online application form. The Department of Labor and Workforce Development will review your organization for pre-qualification and email further instructions to the address listed on the questionnaire.

Grant Title: Clean Energy Technology, Training, and Certification

Grantor: New York State Energy Research and Development Authority

NOTE: Other states have similar programs. Check with your state's designated energy office for details. A list of energy offices is available at http://apps1.eere.energy.gov/state_energy_program/seo_contacts.cfm

Estimated Allocation: Up to \$500,000 per project

Purpose of Grant: (1) To facilitate workforce education in the area of emerging clean energy technologies, specifically large (wholesale) wind and anaerobic digester training throughout New York's System Benefits Charge utility territories. (2) To support clean energy training in New York City for photovoltaic solar, customer-sited wind, fuel cells, solar thermal and geothermal energy technologies.

Application Deadline: Revolving. Check www.nyserda.org/Funding for current deadline information.

Criteria: Co-funding by the proposer of at least 40% is required. Funds can be used to pay for national accreditation and certification programs, market assessments, training facilities and equipment, resource libraries, marketing and outreach, scholarships, internships, apprenticeships, distance learning, and train-the-trainer programs.

How to Apply: Proposers must submit fourteen copies of the proposal with a completed and signed Proposal Checklist attached to the front of each copy, one of which must contain an original signature.
